WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Quarterly CY 2018 General Office Supplies Requirement of the Office of the Ombudsman for Lot 3 (PB 2018-14)** and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Three Million Eighty Three Thousand Three Hundred Sixty Four Pesos (**₱3,083,364.00**) (hereinafter called "the Contract Price"), to wit:

- (d) the Technical Specifications (Annex "D");
- (e) the General Conditions of Contract (Annex "E");
- (f) the Special Conditions of Contract (Annex "F");
- (g) the Entity's Notice of Award (Annex "G"); and
- (h) the Performance Security (Annex "H")



The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
