You are, thus, required to provide, within ten (10) days from receipt of this Notice of Award, the Performance Security/Performance Bond equivalent to the following:



b) Irrevocable letter of credit issued by a Universal or Commercial Bank: <i>Provided, however</i> , that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.	
c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.	Thirty percent (30%)

Contract signing will be done upon submission of the required Performance Security. Failure to provide the Performance Security shall constitute sufficient ground for cancellation of the award and forfeiture of your Bid Security.


